Welcome

The meeting was called to order at 8:23 PM by Mr. Tarquinio, Board Member.

Public Notice

Ms. Arnold stated that the meeting had been publicly noticed through a parent email and posted on the doors. It was also placed on the website.

Minutes

Board reviewed and approved August 2, 2013 minutes.

Principal's Report

Ms. Silver congratulated the school for receiving the National Parent Choice award. Ms. Arnold stated that we had 94% of students returned to Imagine from one year to the next.

Mr. Cristiano, a parent of a student at Imagine, is donating all equipment and labor and will apply for permits to put security cameras at all entrance doorways.

Teachers attended 2 days of professional development on August 8 & 9. It was well attended.

We have 198 students enrolled in the middle school. We are budgeted for 198.

On September 28 Dade Recycling will present us with our check for \$1,000 for being the highest recycler. Our school has been recycling ink cartridges and small electronics.

Our Back to School Nights was held on September 11 and was very successful.

SAT Testing was completed for all students. We are waiting for the results.

We had 25 staff members attended the Imagine Mini Forum on August 7.

We had very positive parent support during the recent arrest of a teacher. Since this recent event we are planning an internet safety workshop.

We have placed an ad for a new social studies teacher and will begin interviewing next week. Until we hire a teacher Ms. Dawayni will be subbing in the social studies teacher vacancy.

Our Guidance Counselor, Ms. Schiling, did a presentation with each of the classes on services she offers. She also put together a presentation on Broken Trust in light of the recent arrest of the middle school teacher.

Electronic check in and check- out of students has been implemented and this will also help record volunteer hours electronically rather than manually.

AUDIT REVIEW FOR 2012-2013

Mr. Whitley from Berman Hopkins reviewed the draft copy of the audit with the board. This year's audit was very good because of business practices at the school. All of the prior year audit findings and recommendations were corrected.

Mr. Whitley stated there were no findings in the middle school.

Mr. Whitley spoke about the required communication to tell about changes in accounting practices and any new governmental practice were reviewed with the board.

Board motioned and accepted the audit of the middle school.

GOVERNOR'S RAISES FOR TEACHERS

Mr. Gayle went over the plan when the Governor's raise for teachers is received. There are 9 middle school teachers and 10 specials and elective teachers who are split between two schools. The middle school may receive \$32,793.00. Each middle elementary teacher will receive an equal share of total money received. Specials teachers will receive a split based on their percentages between the elementary and middle school.

Ms. Silver asked how did they figure the percentage. Mr. Gayle explained they took 75% from elementary and 25% from middle. Ms. Arnold said the amount could change in October and February because it is based on the weighted FTE. The first day count was higher and we have to submit a plan to the district as soon as possible. The money could change in February if any adjustments are made. Mr. Tarquinio asked how it will be paid to the teachers. Ms. Arnold stated it would be a raise. Ms. Vernon said we will monitor our budgets. Ms. Silver asked when would the raise go into effect. Ms. Arnold said when the district received the money then the school would receive the money. Ms. Vernon stated that

our district would continue to do collective bargaining until the BTU and the school board approved it. They will not receive money from the state until they come to an agreement. Palm Beach County decided to give the charter schools the money before the money comes through. Adam Miller, Charter School Director, the state will not give the money to individual schools but rather then to the school district once collective bargaining is done. Ms. Arnold stated it has to be used towards salaries. Ms. Silver stated that if the FTE changes that could change the amount of raises that are received. Mr. Tarquino asked how it would be allocated. Ms. Vernon said it is a gross amount. Ms. Forthmuller stated it would not be \$2,500.00 because they have to consider taxes and benefits.

Ms. Arnold explained what the letter states that Mr. Tarquinio will sign. It is a general letter to approve our plan which states the money will be equally distributed among the teachers. The money is based on weighted FTE. We will follow the rules from the district when distributing the money. Ms. Vernon stated the money in November cannot be accrued because there will be less than 26 paychecks. Ms. Forthmuller said they can calculate the raise and retro the raise from the beginning of school year.

Board motioned and approved the Governor's Teacher Allocation Salary Plan.

IMAGINE ACADEMIC EXCELLENCE FRAMEWORK 2013

Ms. Vernon handed out the Academic Framework book to the board. She spoke about the 4 E's. Ms. Vernon referred to page 30 that speaks about the governing board. She stated that it is the schools job is to keep the board and all stakeholders informed about Imagine School's policies and its academic framework, our mission and vision.

3% STIPEND

Ms. Arnold spoke about the 3% and it is received based on the budget being in the black as well as parent surveys. The staff received 2% in June. We had to wait until the audit was finalized before issuing the 3%. The money was accrued in the budget. There were 9 teachers that did not return and this will help the budget. The 3% will be included in the October 11 paycheck. It is a one- time payment. Board motioned and approved the 3%.

COMPENSATION PLAN FOR 2014-2015

Ms. Arnold said it is strictly for individual salary and for instructional staff only. Ms. Vernon that the No Child Left Behind (NCLB) law indicates that teachers will be paid based on student achievement and teacher's evaluation. It is strictly based on performance. If there isn't any money then it cannot be given out but we still have to submit a plan. We are in the process of developing this plan. This plan is due to district by October 1 and is for the 2014-2015 school year. The plan has to be sustainable for the school. An effective teacher could possibly receive a 2% increase and a highly effective teacher a 4% increase. The VAM scores are 50% instructional practice and 50% test scores. Teachers will get marked on how well their class and their school performed. We have received no guidance for a plan. We would like the board to approve the concept that highly effective teachers receive up to a 4% raise and effective teachers receive up to 2%. Mr. Tarquinio asked why this plan has to be submitted. We are a Race to the Top school and Race to the Top will end next year. Ms. Silver asked if we are locked into percentage and Ms. Vernon stated that we are not locked in. Board motioned and approved the Compensation Plan.

OUT-OF-FIELD WAIVERS – see attached

Ms. Arnold spoke about the out-of-field waivers. She stated a teacher remains out-of-field until the courses are completed. The teachers are required to print out all of their courses and send into the state. Once completed the state then adds the new endorsement or subject onto the teaching certificate. Mr. Tarquinio signed the out-of-field waivers.

STUDENT ASSESSMENT MATERIALS

The district would like the student assessment contract by September 25th. Instead of billing us they are going to deduct the assessments out of our FTE. When we give BAT and CoGat tests they will charge us and will take it out of our FTE instead of sending us an invoice. Ms. Silver asked are the amounts the same if they billed you. Ms. Arnold stated that it is actually less expensive for us when they deduct from FTE. We have to pick up our assessments going forward. Prior to this they were delivered to us. Board motioned and approved.

GOVERNING BOARD VACANCY

The board will do two questions. Ms. Vernon explained the procedures for interviewing a new member. You can have 2 boards for each school but the bi-laws state we can have all 5 members on both boards. Ms. Siiver asked what the advantage is to having 2 boards. Ms. Vernon said another school has 2 boards but it is in their bi-laws. There were 5 resumes submitted and candidates were notified when the meeting date was and only 2 attended. Ms. Silver asked do have to choose from these two or can we interview those that didn't show up later. Ms. Vernon said no because it has been advertised so long. Ms. Arnold explained resumes were received for the position. Mr. Ron Veltman and Ms. Leslie Adams were both interviewed.

The board moved and voted to add Leslie Adams to the board for both the elementary and middle school. Ms. Vernon explained the process to Ms. Adams regarding fingerprinting and governing board training so she will be ready to be an active board member at the next meeting.

Public Input

Ms. Adams asked if there any sex education classes are offered. Ms. Clewner stated we have healthy living and 7th grade has Life Science class.

Board Input

Ms. Garland commended Ms. Arnold and staff for handling the situation with Mr. Zilka in a sensitive and professional way.


