Violation #22. Cold holding temperatures

Cold TCS food (Chef salad) tested 42F, not held at 41F or less. Salad was prepared less than 2 hours prior to inspection.- CORRECTED ON SITE

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.
